

End-User License Agreement (Microsoft Corporation)

You have entered into an agreement (the “Original Agreement”) with software-ms.com or any of its affiliated companies (collectively, “software-ms.com”), pursuant to which you have purchased or licensed a software-ms.com device (“DEVICE”) that includes software licensed by software-ms.com from an affiliate of Microsoft Corporation (“MS”). Pursuant to the Original Agreement, the terms and conditions of this END USER LICENSE AGREEMENT (“EULA”) are binding on you and your usage of the software-ms.com device with the MS software. The following terms and conditions of this EULA are made a part of the Original Agreement:

- Ø No Liability for Certain Damages.
